Subject :- Conservation of electricity in Krishi Bhawan –reg

The Hon'ble Agriculture Minister has taken a meeting with officials of CPWD on 15.12.2014 and emphasized the need for conservation of electricity in Krishi Bhawan. He suggested that light points in corridors should be switched on alternately as there is no need for much lighting in the corridors. Similarly, he also suggested that lights in office rooms should also be switched ON to the minimum requirements and switched OFF when not in use. While CPWD will provide alternate switching systems in corridors, officers/staff members in DAC are requested to cooperate in conservation of electricity in Krishi Bhawan by its optimum/ economical use and switch OFF lights of their rooms and other electrical office equipments when not in use and should also ensure that all switches are in off position while leaving the office.

2. All Ministries/ Departments housed in Krishi Bhawan are also requested to issue necessary instructions in this regard to officers/staff members under their control and help in conservation of electricity in Krishi Bhawan.
