G.S.R..... In exercise of the powers conferred by the proviso to article 309 of the Constitution and in suppression of the Directorate of Economics and Statistics, (Class III and Class IV) posts Recruitment Rules, 1969, except as respects things done or omitted to be done before such suppression, the President hereby makes the following rules regulating the method of recruitment to the posts of **Assistant Library & Information Officer** and **Library & Information Assistant** in the Directorate of Economics and Statistics, Department of Agriculture, Cooperation and Farmers Welfare, Ministry of Agriculture and Farmers Welfare, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Directorate of Economics and Statistics, **Assistant Library & Information Officer** and **Library & Information Assistant** Recruitment Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Number of posts, classification and pay band grade pay or pay scale.**- The number of the said posts, its classification and the pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedules annexed to these Rules.

3. **Method of recruitment, age limit and other qualifications, etc.**- The method of recruitment, age limit, qualifications and other matters relating to the said posts, shall be as specified in columns (5) to (13) of the said Schedules.

4. **Disqualification.** - No person,-

- (a) who has entered into or contracted a marriage with person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person

shall be eligible for appointment to the said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax.**- Where the Central Government is of opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving.**- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of , in accordance with the orders issued by the Central Government from time to time in this regard.
